Molinos de Puerto Rico was established in April 1958. Its facilities made a great change in the world of milling industry, especially in Puerto Rico.

The mill produces daily 10,000 hundredweights of wheat flour, 1,300 hundredweights of cornmeal and has a storage capacity of 30,000 hundredweights of flour.

Every month, the company imports about 25,500 tons of grain, and has an elevator with a storage capacity of 90,000 tons. Currently, 90% of production is distributed to the local market and 10% to the Caribbean Islands and east coast of the United States. All products are manufactured under FDA regulations.

Amapola, our retail brand, has always been a trusted brand because it triggers people's childhood memories the way mom used to cook when relating to our logo. Some other products at Molinos are industrial flours such as: Buccaneer, Special 50, Triunfador, Full Power High Gluten, Garland Cracker, Gran Galleta and Queen Quality; most of these are well known in the bread and food service industry. Our brand has been awarded for "Quality of Excellence" by the Puerto Rico Products Association.
