THE CMA'S CONSTITUTION

continues...

As mentioned, in our previous Newsletter clauses will be randomly extracted from CMA's Constitution to educate and raise awareness of some of the laws governing the CMA.

4.0 Membership:

4.3 Each member organization shall appoint one individual person to represent it and vote on its behalf at general meetings of the Association. In the event of such individual person resigning or otherwise leaving an organization he or she shall immediately cease to be a representative of such organization.

4.5 The Executive shall have the right:

4.5.1 to appoint Honourary members at their discretion. Honourary members shall not be entitled to vote.

4.5.2 to appoint to reject applications for membership; and

4.5.3 good and sufficient reason to terminate the membership of any individual or organization provided that the individual member concerned or the individual representing such organization (as the case may be) shall have the right to be heard by the executive committee before a final decision is made.

6.8 The General Assembly has the following duties:

- 6.8.1 Agree on changes to these by-laws and interpret them.
- 6.8.2 Agree to dissolve the Association
- 6.8.3 Accept the Presidential Annual Report and review of the Association's Financial situation.
- 6.8.4. Decide on the plan of action the Executive Committee should follow during the following year.
- 6.8.5 Vote on membership for the Executive Committee.
- 6.8.6 Appoint one or more qualified auditors and may determine their remuneration (if any).
